## ST. JUDE'S ACADEMY BEFORE & AFTER SCHOOL CARE PROGRAM AGREEMENT & REGISTRATION

### I. BEFORE & AFTER SCHOOL CARE PROGRAM AGREEMENT 2020-2021

In consideration of the acceptance by St. Jude's Academy of

as a student(s), I agree to pay all Before & After School Care Program fees, dues, accounts and other indebtedness incurred by the student(s) or on the student's(s') behalf. I understand that the obligation to pay the fees per term of the Before & After School Care Program is unconditional and that no portion of such fees so paid or outstanding will be refunded, credited or cancelled in any event from the Before & After School Care Program.

I further understand that:

- (a) This is a per term commitment to the Before & After School Care Program.
- (b) The first payment is due upon registration.
- (c) Payment is due one month in advance.
- (d) The monthly fee calculated will be based on the option selected per student.
- (e) No student will be admitted for a new term if any indebtedness to St. Jude's Academy with respect to Before & After School Care Program for the previous term(s) remains unpaid, including interest.
  - (i) Should any outstanding accounts exist, the first payment may, at the option of St. Jude's Academy, be applied towards any outstanding accounts.
  - (ii) Registration and enrolment of the student(s) will not proceed until all accounts are settled and paid in full.
- (f) This document is considered a binding contract upon signing this agreement.
- (g) St. Jude's Academy reserves the right to remove a student from the Before & After School Care Program that is exhibiting social, emotional, or behavioural needs that are greater than the Before & After School Care Program capabilities.
  - (i) Upon student removal by St. Jude's Academy, any prepaid Before & After School Care Program fees will be refunded.
  - (ii) St. Jude's Academy recognizes that special circumstances may occur where it may be reasonable for St. Jude's Academy to waive any of the terms of this agreement. I understand that any waiver of any of the terms of this agreement shall be made at the sole discretion of St. Jude's Academy taking all reasonable factors into consideration.
- (h) The Before & After School Care Program will run from 7:30 am to 8:30 am and from 3:45 pm to 6:00 pm. Members enrolled in the program will not be permitted to exceed these time frames.
